**North Northamptonshire Gypsy and Traveller Local Plan

Planning and Compulsory Purchase Act 2004
The Town and Country Planning (Local Planning) (England) Regulations 2012

In line with Regulation 18 of the Town and Country Planning (Local Planning) (England) Regulations 2012 and the Planning and Compulsory Purchase Act (2004), North Northamptonshire Council is preparing a Gypsy and Traveller Local Plan for the area.

The Gypsy and Traveller Local Plan will address the accommodation needs of gypsy and travellers in North Northamptonshire. The Plan will provide policies and site allocations and is intended to cover the period to 2041.

The Scope and Options Consultation is the first stage in preparing the plan, no decisions have been made yet. At this stage the Council is inviting comments on the key issues to be addressed by the Plan, and the proposed scope and contents of the Plan.

The consultation period starts on Wednesday 5th April 2023 and closes at **midnight on Wednesday 31st May 2023**.
